The candidates admitted under this scheme will be provided (i) 3-Year course fee exemption (ii) Rent free hostel accommodation (iii) Meal allowance (iv) Scholarship (v) Books & uniform allowance etc.

### INSTRUCTIONS FOR ADMISSION (SESSION 2021-22)

#### 1. Eligibility :-

- (i) The Handicap Disability should be 40% or more.
- (ii) Passed 10th Std/ SSC Examination.
- (iii) Obtained at least 35% marks (33% in case of candidates belonging to Scheduled Castes and Scheduled Tribes category) at the qualifying examination.

2. **Basis of Admission:** Admission in Diploma Engg. Course shall be made on the basis of (i) Merit of Secondary/Matric/10th or equivalent qualifying examination. (ii) Branch Suitability Certificate/ Vocational Evaluation Certificate issued by the counselors from VRC (Vocational Rehabilitation Centre). Admission committee and VRC members have the right and will to scrutinize & counsel the candidates for their suitability for a particular branch.
3. The application form is available free of cost in the institute and can also be downloaded from website of the institute [www.gpsirsa.ac.in](http://www.gpsirsa.ac.in)
4. The completely filled application form along with the self-attested photocopies of Disability Certificate issued by medical board, 10th Mark-sheet, Character Certificate, Reservation Category Certificate, Income Certificate (only for BC-A & BC-B category candidates), Domicile/Residence Certificate, Aadhaar Card and Bank account details should reach **The Principal, Govt. Polytechnic, Rania Road, Sirsa-125055 by 29.11.2021 (upto 10:00 am)**
5. The counseling will be held on **29.11.2021 (11:00 am)** at Govt. Polytechnic, Sirsa.
6. Candidates should report personally at the time of counseling along with their original documents and two sets of self-attested photocopies of Disability Certificate issued by medical board, 10th Mark-sheet, Character Certificate, Reservation Category Certificate, Income Certificate (only for BC-A & BC-B category candidates), Domicile/Residence Certificate, Aadhaar Card, Medical Fitness Certificate and Bank account details, three passport size photographs and Refundable Security of (i) Rs. 2000/- for getting admission in the course (ii) Rs. 2000/- for taking hostel facility and (iii) Rs. 2000/- for mess/meal facility.
7. Haryana State Reservation policy at the time of counseling will be followed.
8. Vacant seats if any after 1<sup>st</sup> Phase of counseling will be converted into open general category and after that 2<sup>nd</sup> phase of counseling will be held on same day.
9. Mentally retarded, deaf & dumb and blind candidates are not suitable for admission in the scheme.
