**Rs. 600/-** : For Re-evaluation per subject

**Rs. 1000/-** : For Photocopy of Answer-sheet per subject alongwith **undertaking**.

The students are strictly instructed to submit the application form on the same day in the examination branch of this Institute. The Rechecking / Photocopy fee **must be** deposited through State Bank of India ([www.onlinesbi.sbi](http://www.onlinesbi.sbi))

SBI Collect → Educational Institute → Government Polytechnic Sirsa → Payment category → Examination fee → Rechecking or photocopy.

**Note:** The students must note down their reference number after successful payment.
